- 4. A non-refundable fee is required for each request. If the Bureau has no record for the information requested or the data supplied is insufficient, the fee will be applied to the cost of the search.
- 5. **If requesting a microfilm copy of a document**, also complete Section F. You must be specific in providing the type and date of the document. If there are several citations on the record, the cost is \$10.00 per citation. You need to provide the date of the violation/action to clearly identify the citation(s) requested.

A 10-year record is for employment purposes only. FULL HISTORY ..... Includes name, address, driver number, date of birth, class, license status, Departmental actions and violations for the (\$10.00 fee) complete history of the driver on file in Pennsylvania. CERTIFIED RECORD..... Includes name, address, driver number, date of birth, class, license status, Departmental actions and violations for the (\$34.00 fee) complete history of the driver on file in Pennsylvania certified by the Department. **MICROFILM** DOCUMENT...... Copies of documents retained by the Department are available for purchase from the microfilm file. You must be specific (\$10.00 fee) as to the type of document and the date of the violation/action. **CERTIFIED COPY** OF DOCUMENT..... Copies of documents from the microfilm file that have been certified by the Department. (\$34.00 fee)
